The undersigned agrees that Safety Harbor Montessori Academy has the right to exclude from school any student who is deemed in the sole and exclusive discretion of the Administration, to be interfering with the health, safety, or educational development of him (her) self or of any other student(s) attending the school. The undersigned agrees that signing this agreement signifies parent and student adherence to all policies, rules, and regulations of the school, from time to time established.
